### Academy of Root Development (Australia) Inc 2020 Annual Report

ARD has been working with communities in rural Bihar since 2005, when we started a programme to support women and their families through Self Help Groups, Micro-finance and Income Generating Activities.

In 2013/14 the Indian government implemented a nation-wide rural support initiative, which meant we were unable to continue with our programme. We instructed our staff to enquire of the women in the villages what would be their next greatest need, to which they replied Reproductive and Child Health, Vocational Training and Literacy Centres for illiterate adolescent girls.

We then established a programme in Guraru Block, in Gaya District, Bihar, under the name of Women's Empowerment in Indian Villages (WEIV) to deliver two programs to support the women and their families:

### Reproductive and Child Health

The Reproductive and Child Health programme has now entered its sixth year of operation. Our aim is to impart practical information and bring about attitudinal changes in health and well-being. The RCH program addresses contraceptive awareness, antenatal education and support, maternal and child well-being and nutrition. Gender discrimination awareness is a strong focus of our work and we are working with adolescent girls and boys to this end.

### **Literacy Centres**

During the years 2015-17 ARD(Australia)Inc established eight Literacy Centres for poor adolescent girls who otherwise would not be engaged in the education system. The girls are taught Hindi reading and writing, functional mathematics and basic English.

We have a staff of thirteen (13) in the RCH programme and eight (8) teachers in the Literacy Centre programme.

Each month ARD(Aust)Inc sends around AU\$3,000 to pay the staff and meet the WEIV administration expenses in India. 100% of all donations go directly to India. All work in Australia is done on a purely voluntary basis and any local administration expenses are met by local fundraising initiatives.

#### The Time of Covid-19

The COVID-19 pandemic is having a huge impact on people world-wide.

We gave all WEIV staff paid leave dating from 14th March in line with the closing of schools in India. We saw the danger coming and realised the need to act swiftly. We will revise the situation progressively, however staff are on paid leave at least until the government of India revises its schools closure timeframe.

In India, people were locked down inside their own homes from 25th March through to the end of April. People were allowed out only to buy food and obtain medical supplies/support. The India-wide restrictions eased, but were reinstated during July.

WEIV Staff are greatly aware of the need to self-isolate and wash hands regularly. Hand washing is one of the health awareness strategies WEIV staff teach to programme participants. Staff are constantly posting to the WhatsApp group to spread awareness and support each other at this time.

### **Smart Phones**

Commencing January 2020, all staff members were required to purchase smart phones with the assistance of a subsidy, plus a loan from ARD(Aust)Inc. This was in order for them to be able to do biometric attendance recording and free up some of the staff who were in the role of supervisors, travelling around checking on staff attendance, thereby enabling them to run additional Reproductive and Child Health groups.

The smart phones have given them access to the internet which is new for most of them. This is really valuable at this time and they are sharing health information with each other regularly, as well as checking in with each other.

We have created a Teachers' WhatsApp group and an RCH WhatsApp group and we are easily able to communicate with them now using Google Translate.

Staff member Renu Kumari explains how her family is dealing with the Covid-19 lockdown:

"Ever since the lockdown started I am spending my life working with my entire family while doing household work and taking care of social distance, and I am spending time in between looking at my mobile watching Ramayana and Mahabharata."

"My two children are also studying at home using the mobile. My husband is also living at home, watching Ramayana and Mahabharata from mobile and listening to news."

"I also advise the people of the neighbourhood to maintain social distance so that everyone can lead a healthy and happy life. I also advise people in other villages to take care of social distance and cleanliness by talking to them on the phone."

We are working to establish ways that staff can continue to build on their connection with the participants in the programme to support them in maintaining their health and the health of their families during this time. We are also working on ways to keep the teachers of the Literacy Centres in contact with their students via mobile phones, to enable them to continue the learning process during the lockdown period.

#### In Australia:

We have been hampered by the Covid-19 pandemic in that we are unable to hold fundraising activities to maintain our funding levels.

Donors have stated their support for our strategy of paying staff their full salaries whist the lockdown is in place as a way of ensuring the families do not suffer excessive hardship. We continue to monitor the situation and will reintroduce face-to-face groups when the Government of India determines that it is safe to do so.
